Motion by Richard Novotny to accept the bills second by Kevin Oster, motion carried with all in favor and none nay.

That Lots Six (6), Seven (7), Eight (8) and Nine (9) of Block Twenty Seven (28) Original Townsite of the City of Lidgerwood, Richland County, North Dakota shall be zoned Residential and Commercial.
